S1 service description

The dog day care ensures during the agreed length of stay a species-appropriate accommodation of the dog. The dog day care center will notify the dog owner immediately if his dog is experiencing health or mental disorders or the dog is experiencing familiarity problems that exceed the normal level.

S2 health / vaccinations

a) The dog owner assures that the dog has full vaccine protection (distemper, hepatitis, parvovirus, parainfluenza (kennel cough), leptospirosis and rabies) and is dewormed.

b) The dog owner assures that the dog is free of infectious diseases at the time of delivery.

If the suspicion of a disease exists, the dog owner is obliged to expressly point out.

c) The dog owner assures that the dog is not in stock at the time of delivery.

S3 liability insurance

The dog owner assures that there is a valid liability insurance for the dog.

S4 Acceptance of costs

The dog owner agrees that all efforts, regardless of cost, should be made by a veterinarian or other third party in case of illness or in case of accident of his dog. The dog owner assumes the resulting costs.

S5 liability

The dog day care is liable to the dog owner for themselves and their vicarious agents - for whatever legal reason - only for intent and gross negligence and culpable injury to life, limb and health. The dog day care center is therefore not liable in cases of slight and moderate negligence, unless it is the culpable violation of essential contractual obligations. In the latter case, the liability is limited to the contractually typical, reasonably foreseeable damage. The above limitations of liability apply in particular to damage to the dog and loss or death of the dog.

The dog daycare is not liable in particular

- Damage to the dog
- Damage to the litter in semi-pregnant / pregnant females
- birth defects in pregnant bitches
- Covering a bitch in heat
- Damage caused by unrecognized contagious diseases of a dog in the dog day care center

The owner releases the dog day-care center from claims of third parties caused by the dog being accommodated.

S6 Period of agreement and remuneration

a) single day

The date of the single booked day has to be agreed in advance.

b) a trading card with several days

The trading card is valid for the specified number of days. The trading card is valid for one year. The respective dates are to be agreed in advance.

c) a season ticket

The season ticket is valid for the specified period.

The signing of the contract obliges the dog owner to pay the corresponding amount. The settlement of the amount is due at the latest at the first delivery of the dog. A refund or partial refund due to non-arrival or premature termination by the dog owner is not possible.

d) Cancellation of appointments / no-shows

Appointments that are not canceled at least 2 business days before the booked date will be charged according to the booking.

S7 pickup

If the dogs are not picked up without agreement at the agreed time, the dog day care center is entitled to accommodate the dog in a shelter. All related costs will be borne by the holder.

S8 Final Provisions

a) Changes, additions or extensions of the contract must be made in writing.

b) Should one or more of these provisions be or become ineffective, this shall not affect the validity of the remaining provisions. The parties undertake to remedy the invalid or ineffective provision by a new provision that comes as close as possible to the invalid or ineffective provision.

c) With the o. g. I also agree to conditions for subsequent stays of my dog, provided that there are no changes. However, should changes occur, dog owners and pension are obliged to inform each other.
